QUALIFICATION DETAILS:

To qualify for a trip for 2 (not including airfare), you must first qualify yourself for a trip for 1, and then have someone in your first generation also qualify for a trip for 1. Each Viv Life Consultant or business unit is limited to earning a spot for only one guest. Consultants can earn credit toward the cost of the trip as illustrated in the chart above. Trip credit earned for each rank is the total for achieving that rank and is not additive. Credits applied to Guatemala cannot be used towards attending the Dominican Republic One At A Time Experience however both trips can be earned by incremental business activity exceeding the Guatemala trip requirements. Trip for 1 qualifiers who cannot attend the trip, may transfer their trip credit to another traveler to Guatemala, upon written approval from Viv. Credit is not transferrable for future trips, cash or commissions and all rewards are in addition to any rewards received under the compensation plan.

COMMISSION DETAILS ON NON-CONSULTANT TRAVELERS:

Any Viv Life Consultant that sells a trip to a non-Viv Life Consultant will earn \$150 in personal sales commission. An additional \$150 in Commissionable Volume will be generated for the upteam.

WHAT'S INCLUDED?

FLIGHTS: Flights must be booked independently, and flight confirmations must be emailed to Viv no later than April 5, 2019. A flight reimbursement for an economy fare up to \$450 will be provided per the qualifications noted in the chart above.

ACCOMMODATIONS: All accommodation costs are included. During the service portion we will be in very basic dormitory style accommodations with shared bathrooms and double occupancy for luxury portion of the trip.

MEALS: Breakfast, lunch and dinner are included for each day during both the project and luxury portions of the trip. Additional drinks and snacks are at each individual's own expense. Food expenses at the airport are not included.

ACTIVITIES AND TRANSFERS: All pre-arranged group activities for the trip are included, as well as transfers to and from the activities. Any activities booked outside the pre-arranged group activities will be at the individual's own expense.

GENERAL EXPENSES: It is recommended that individuals bring local currency for any incidentals, snacks and shopping/souvenirs, which are not covered by Viv.

TRAVEL INSURANCE: Travel insurance is not included. It is recommended that individuals take out their own personal travel insurance to cover any potential issues, such as lost items, medical expenses, canceled flights, etc.

Any consultant who earns rewards via this promotion must be an active consultant in good standing with Viv at the time the promotion rewards are paid.
